### Anvil Mining Appoints Philippe Monier as Vice President Corporate and CFO

**Montréal, Canada: Anvil Mining Limited (TSX, ASX: AVM)**, (“Anvil” or the “Company”), today announced the appointment of Mr. Philippe Monier as its Vice President Corporate and Chief Financial Officer, effective October 1, 2010. Philippe will succeed Lui Evangelista who has been Acting CFO since the retirement of Craig Munro earlier this year.

Philippe brings with him significant corporate, M&A and banking experience in the natural resources sector and I look forward to working closely with him and continuing to build a strong future for the Company.
